**THE PASTORAL PLAN FOR PARISH RENEWAL AND RESTRUCTURING**

**PARISH EVALUATION INSTRUMENT**

(This instrument should be filled out confidentially by everyone who participates in the process.)

Please reflect honestly and prayerfully on the ten CRITERIA FOR DETERMINING PARISH VIABILITY in ATTACHMENT C. You are not expected to provide a written answer for every criterion. They should stimulate thought and discussion. Discuss them freely with fellow parishioners. Since a wide range of opinions will be shared, it will not be possible to record in writing every opinion. However, a discussion group leader should be designated to provide a BRIEF summary of the discussion of each criterion indicating the presence or absence of a consensus about what seems to be working very well in the parish and what is not working well and is in need of serious improvement.

At the conclusion of the meeting(s) of your group, please indicate your true and honest judgment about each criterion using the scale of one to ten by circling the appropriate number, using “1” as the lowest and “10” as the highest. For example, if you think your parish is very strong in Worship and Spiritual Life, you would grade it 9 or 10, but NO LOWER than 8. However, if you think your parish is weak in that area, you would grade it 1 or 2 but NO HIGHER than 3. If you feel you do not know enough about a criterion, simply write, “I do not know enough to evaluate this area.” At the end of this instrument, please express your true opinion about the viability of your parish. You are urged to sign the completed evaluation instrument; however, you are not required to do so. Please give it to your pastor, administrator or parish life coordinator. Thank you for taking the time to give this evaluation serious consideration.

(All of these responses are to be summarized by the pastor, administrator, or parish life coordinator and sent to the Vicar General. All individual responses must be forwarded as well.)
